IMPORTANT INSTRUCTIONS

1. **Candidates are required to send their willingness/ unwillingness certificate for admission in Sainik School Nalanda as per format available on e-counselling portal of AISSAC 2024 to the school Email ID ssnalanda@sainikschoolsociety.in by 19 Sep 24.** The candidates will be called only after receipt of the Willingness Certificate and no candidates will be entertained without willingness certificate for admission at Sainik School Nalanda. Only willing candidates will be called for medical examination and further for admission process.

2. The initial medical examination of the above candidates will be conducted at Sadar Hospital Biharsharif (Nalanda), Bihar. Candidates are required to report to the medical examination venue at 0800h as per date intimated to candidates along with Medical Examination Proforma and other mandatory documents which is available on e-counselling portal of AISSAC 2024.

3. Documents Verification will be carried out on same or next day of the medical examination at Sainik School Nalanda. Candidates are advice to check their email/ school website regularly to avoid any delay.

4. Admission of these candidates will be subject to their medical fitness. The candidates declared medically unfit have a chance to appeal for an Appeal Medical Examination. Therefore, those who wish to make an appeal against the Initial Medical Board Findings must apply in writing to the Principal, Sainik School Nalanda within two days after completion of initial medical examination along with medical opinion of the competent medical authority to counter the findings of the Initial Medical Board.

5. After examining the appeal and medical opinion produced by the parents/guardians, the Principal, Sainik School Nalanda may arrange an Appeal Medical Examination for the candidates. The candidates permitted to appear for Appeal Medical Examination will be required to appear before the Appeal Medical Board at the designated hospital on the date and time as specified by the School at their own expenses and risk.

6. The candidature of the candidates will be cancelled, in case of failure to report to the school on the date stipulated for the Medical Examination/ Admission or failure to submit/ produce the requisite documents. Candidature can also be cancelled even after admission, if, it is, found at any stage that the information/ documents submitted by parent/ candidate are false.
